1. Introduction

RA Cellular customers in selected stores within the Emalahleni municipality will stand a chance to win instant data rewards or shopping vouchers at point of purchase, by simply purchasing a 120MB weekly data voucher for R17 or by recharging with a MTN R15 or more. 2. Duration of the Promotion

The Promotion is going to be available from 01 December 2019 and ends on 31 January 2020 (“Promotion Period”)

3. Who will be Eligible

- 4.2. Customer to recharge at a selected touch point that use RA Cellular terminals in the Emalahleni municipality – POS will be supplied for selected outlets.
- 4.3. Customers who purchase any of the qualifying vouchers (MTN R17 Weekly Data or MTN R15 or more), will automatically be entered for the random draw.
- 4.4. Randomly selected customers will receive an instant data reward or a shopping voucher at the touch point when purchasing any of the qualifying voucher denominations listed above.

5. Instant Prizes

- 5.1. Winner/s stand a chance to win an instant prize upon purchase of selected recharge vouchers.
